<u>ORDER</u>

3. All papers previously filed and served to date in the Related Actions are hereby deemed part of the record in the Consolidated Action.

4. This Order shall apply to any subsequent case alleging the same or substantially similar allegations filed in, transferred to, or removed to this Court. Plaintiffs shall file a Notice of Related Case whenever a case that should be consolidated into this action is filed in this District. If any party objects to such consolidation or otherwise wishes to seek alternative relief, they shall do so within ten (10) calendar days. If the Court determines that the case is related, the clerk shall place a copy of this Order in the separate docket for such action and make the appropriate entry on the Master Docket.

5. Except as specifically set forth herein, all other existing case management orders shall remain in effect.
